All Entries- Please attach a 1-2 page project description and photos (at least 1 interior and 1 exterior but more is always helpful) to provide additional information above and beyond technical specifications. These may include healthy home features (materials and finishes), home siting, renewable energy, material selection, innovative design features, customer feedback, other non-energy or comfort features, etc. Please also include project costs not including land, site work, or renewables.
