## Program Eligibility and Exclusions

Rebate offer is available to all owners of residential rental properties that are served by Vermont electric utilities. All products must be installed in a residential rental property in the State of Vermont. **Owner-occupied units and seasonal / short-term rentals (less than 6 months of continuous occupancy) are not eligible for rebate offers listed on this form.**

Rebate is subject to change without notice. In the event a rebate is discontinued or changed, submissions will be honored at the higher amount if the qualifying product was purchased prior to the effective date of the change, with installations and rebate submission occurring within 30 calendar days of the change.

All equipment must be new, installed in Vermont, and listed on the Qualifying Products List (or meet Efficiency Vermont qualifying criteria) at the time of purchase. Used, rebuilt, or refurbished equipment is not eligible.

For any single item, payment will not exceed the purchase price, and excludes all other costs including shipping, sales tax, or disposal/recycling expenses (installation costs of HVAC and refrigeration equipment, and installation and freight costs of agricultural equipment are eligible).

Properties or units served by the following VPPSA member utilities are eligible for an additional bonus of \$800 for installing 4+ eligible products in a unit or property: Barton Village Electric Department, Enosburg Falls Electric Department, Hardwick Electric Department, Jacksonville Electric Company, Johnson Water & Light, Ludlow Electric Department, Lyndon Electric Department, Morrisville Water & Light Department, Northfield Electric Department, Orleans Electric Department, and Swanton Electric Department.

Customer is responsible for any tax liability associated with rebate payment. Allow 60 calendar days for delivery of payment. Incomplete or missing information will delay processing.

IBM, Global Foundries, Omya, and Vermont electric utility companies are not eligible.

Cannot submit rebate for the same unit in the same calendar year. Property owner can submit more than once per year, but not for the same unit.
